Potential Health Effects

Inhalation: Vapors and mists will irritate the respiratory tract and nasal passages. When heated to temperatures exceeding 300° F (150° C) in the presence of air, silicones may form formaldehyde vapors. Formaldehyde is a potential cancer hazard and a known skin and respiratory sensitizer. Vapors irritate the eyes, nose and throat. Safe handling conditions may be maintained by keeping formaldehyde vapor concentrations below the OSHA permissible limit. The silane is a skin and eye irritant and may cause skin burns. Overexposure may cause coma and respiratory failure. The low concentration makes such overexposure unlikely and minimizes its affect on health and safety.

Skin contact: May cause skin irritation with discomfort or rash.

Eye contact: Vapors may irritate eyes. Contact with eyes will cause irritation.

Ingestion: Moderately toxic by ingestion. Not expected under normal conditions of use.

Existing conditions aggravated by exposure:

Skin disorders.

4. FIRST AID MEASURES

Inhalation: Remove to fresh air. If discomfort persists seek medical attention.

Skin contact: Wipe off paste with paper towel or cloth. Wash with soap and water.

Eye contact: Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Get medical attention.

Ingestion: Do not induce vomiting. Keep individual calm. Obtain medical attention.
